### Relocating and setting up a company: uncomplicated, efficient, straightforward

Setting up a business

In Appenzell Ausserrhoden, entrepreneurial ideas and growth plans meet with unbureaucratic solutions, expert advice and active support. The manageable size of Appenzell Ausserrhoden is a decisive factor for your success and that of your company: setting up company is easy - there are many flexible possibilities for support, and well-established networks.

In Appenzell Ausserrhoden, setting up a business is very easy.



Once your capital is paid in, the company can be founded within a few days. It takes about 3 to 4 weeks to acquire legal effect for third parties.

Certified public accountants and law firms can offer you expert support for setting up your company.

The foundation costs vary depending on the share capital and the effort involved. The fees for founding an AG or GmbH are 1,500 to 2,000 Swiss francs (costs for preliminary examination, notarisation, registration, publication). In addition, there is stamp duty amounting to 1% of the share capital, with the first million being tax-free.

#### Continuing boom

The fact that Appenzell Ausserrhoden is an entrepreneur-friendly location can also be seen from the Commercial Register statistics. For over 20 years, the number of resident businesses has been steadily increasing. Since the turn of the millennium, the number of businesses in the canton has more than doubled.

### Overview of the legal framework

Anyone who wants to set up a company must first decide on a legal form. Swiss law distinguishes between partnerships and corporations. While corporations are only liable with the company capital in the event of bankruptcy, partnerships are closely linked to the owner of the company. The partners are therefore also liable with their private assets. The following table gives a good overview of the most common corporate structures.

#### Comparison of the most important legal forms

Depending on your initial situation and objectives, there are various other options available: participation in a Swiss company, acquisition (majority shareholding) of an existing business, merger with a Swiss partner, joint venture, strategic alliance (with or without capital participation).
